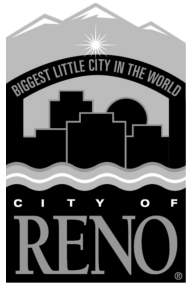

Jon Shipman, City of Reno Assistant City Attorney, provided clarification after some discussion regarding implementation of the Regional Plan. It is important to understand the distinction between legislating (passing ordinances) and quasi judicial decision-making when a conditional use permit or variance comes in front of you. Those are two different types of functions. The zoning is what really dictates what uses are appropriate and what development standards are going to be put on those uses. That should not be confused with when you have a conditional use permit before you. When a conditional use permit comes before you, this body has already determined that the use is appropriate through the zoning. So the function of the body at that point is not to implement the master plan because it has already been implemented in the zoning at that point. The function of the body at that point is to look at if there are specific things that need to be put in place to mitigate that use. He provided examples of that level of analysis. It is not the time and place to require things like solar. The time and place to do that is when you are doing your development standards and that needs to be implemented in code. That is a different exercise than when a conditional use permit comes in. All you are trying to do at that point is mitigate specific conditions on that site that might effect the neighbors. It is not the time to render policy broadly about data centers, for example.
