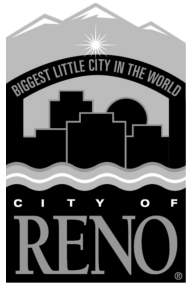

Mayor Schieve discussed the process for appeals of Hearing Officer decisions and stated they should come to City Council instead of going to the court.

Johathan Shipman, City of Reno Assistant City Attorney, answered questions from Council regarding the current and past processes for those appeals. He clarified that Council always has the right to pass additional standards by ordinance. He also clarified that if appeals come to Council, they would be an impartial body and would not have the ability to direct staff to appeal a Hearing Officer's decision.

Mayor Schieve discussed the need for more background information at a future meeting on why the previous Council did it that way.

Council Member Duerr stated if this does end up coming back to Council, she would advocate for a streamlined process that provides clarity on who can appeal. She suggested allowing only the business owner involved to appeal the decision.

Mayor Schieve asked if Council can appeal a municipal court decision.

Mr. Shipman stated he will look into it to confirm if they can do that.

Angela Fuss, City of Reno Development Services Assistant Director, presented the staff report.

Council Member Duerr discussed the need to listen to our constituents about their data center concerns. We should take a look at it based on the input we are getting from our residents and talk to TMWA about their water use, talk to NV Energy about the energy use, and talk about the noise impacts to see if we need to adopt some special regulations to make sure we are being properly proactive on this topic.

Ms. Fuss confirmed for Vice Mayor Taylor that Storey County uses the same water and the same power grid as Reno.

Vice Mayor Taylor stated that Council was packed today with people that were concerned about the resources that go into data centers and three data centers got approved in Storey County and they use the same resources that Reno does.

Ms. Fuss explained for Vice Mayor Taylor that City Council does not put regulations on power. When a building permit comes in, a building permit is not issued unless they provide proof that they have approval from the sewer body, TMWA, and NV Energy for the project.

Vice Mayor Taylor asked if the conditional use permit process is more stringent than a text amendment.

Ms. Fuss explained that the conditional use permit process allows the public body to weigh in and add requirements above and beyond the rules in the zoning code.

Jonathan Shipman, City of Reno Assistant City Attorney, confirmed for Vice Mayor Taylor that whatever Council decides today does not impact anything that has been brought before or that is in process for appeal.

Council Member Anderson referenced comments made about data centers somehow interfering with fire fighting and she asked for information on fire prevention measures at data centers.

Dave Cochran, City of Reno Fire Chief, stated that data centers use very little to no water for fire suppression because water would do a lot of damage to their very expensive equipment. We hold them to fire code requirements and make sure they have a system that will mitigate any fire that starts but they are self-motivated to go above and beyond anything we would require.

Chief Cochran confirmed for Mayor Schieve that data centers are not typically a high fire risk.

Ms. Fuss reviewed for Council Member Martinez the items that trigger a review by the Regional Planning Agency. It does not include a trigger for power usage. It does include a trigger for when power is being added to the grid.

Ms. Fuss answered question from Council Member Ebert regarding tax abatements for data centers. She explained that the city does not have jurisdiction over that.

Council Member Ebert stated that even though we are not the ones necessarily granting it, the property tax abatements do affect our budget when we are paying for things like police, fire and other services.

Ms. Fuss explained that they looked locally at how much data centers are bringing in. While they may have used abatements, they are bringing in a lot of money to the region.

Council Member Ebert referenced an earlier comment about nobody giving public comment about data centers at Storey County's meeting and stated the population of Storey County is four thousand so it may not be an issue to the population there like it would be here to have those kinds of developments and the tax abatement impacts. She also asked about enforcement of noise ordinances.

Ms. Fuss confirmed that citations can be made if noise ordinance requirements are not met.

Ms. Fuss explained for Mayor Schieve the definition for data centers.

Council Member Duerr discussed the need to identify the potential impacts of data centers and talk through whether they need to mitigate those or not. This is an opportunity to put our sustainability plan into action.

Vice Mayor Taylor asked for staff's professional opinion on whether a text amendment or a conditional use permit would be better if we want to regulate and look at these as individual projects and have more say in what we want them to look like.

Ms. Fuss explained her concern with a text amendment that adds specific requirements for data centers is that they are all different and would end up needing variances. The intent of requiring a conditional use permit is so we can look at them on a case by case basis. If there are key things Council is concerned about, minimum requirements can be included as part of a text amendment.

Vice Mayor Taylor asked staff what is not working with what we are already doing.

Ms. Fuss stated from the Planning Commission's perspective, they don't know what you want to regulate in terms of water, power, and noise. From a City Planner perspective, it is in code. We have the safeguards to say how we will address all of the concerns.

Ms. Fuss confirmed for Vice Mayor Taylor that we have not historically addressed power usage and most jurisdictions do not do that.

Vice Mayor Taylor stated she does not know what problem we are trying to solve besides what was said about the Planning Commission not understanding the direction. She believes staff gives them all the information they need and if they stay within the guidelines of a land use decision, we can make thoughtful decisions.

Ms. Fuss explained for Council Member Anderson that the PUCN regulates power issues for projects.

Council Member Anderson stated the conditional use permit provides maximum transparency and allows us to learn and optimize project by project.

Council Member Ebert discussed the need for more guidelines in a text amendment. She would like to see pretty rigid restrictions around noise and the use effluent water and perhaps a percentage of their power usage be renewable energy.

Mayor Schieve discussed the need for research on some of the requested regulations or standards and asked staff how we get there.

Ms. Fuss discussed the process if Council decides to initiate a text amendment to address data centers.

Vice Mayor Taylor stated she is not sure she wants to make text amendment and also have the conditional use permit process on top of that. That seems like more regulation when it is already in the conditional use permit process.

Ms. Fuss discussed potential unintended consequences of saying all data centers need to tie in to effluent.

Council Member Duerr suggested not getting into detail and micro-managing how they do their cooling but make a more global statement like Clark County that says they can't use evaporative cooling or high water intensive cooling.

There was discussion regarding how much time is involved in the text amendment process.

Mayor Schieve stated she feels they are aligned and that they can do it now based on what they already have in place because it has to go to the Planning Commission.

Ms. Fuss stated if that is the direction Council wants to go, we won't do an amendment to Title 18 but will keep the conditional use permit process. She has heard the things that Council has said and as staff reviews these things they can keep that in mind and address them on a case by case basis.

Vice Mayor Taylor stated that is where she is at.

Council Member Duerr stated it is important for Council to have staff take a look at it and come back whether or not we adopt a text amendment and she made a motion to initiate a text amendment.

Ms. Fuss explained for Mayor Schieve that would not eliminate the current CUP process.



Mayor Schieve stated she does not want to go six months down the road on a text amendment.

Council Member Anderson stated she is leaning toward not adding regulations here when we have a maximally flexible and a maximally transparent process through the conditional use permit.

Council Member Duerr discussed why it is better to be more clear and that is what the Planning Commission is asking of Council. They are saying they don't want to vote if we haven't given them criteria like we have for other issues.

Mayor Schieve stated she does not see why they can't take the same approach they did with horses for example.

Council Member Duerr stated if we add a condition on water and it is not supported in our ordinances, we would not sustain an appeal.

Council Member Duerr repeated her motion to initiate a text amendment.

Mayor Schieve stated what she worries about is that it takes forever and takes up a lot of resources. I feel like the Council is ready to put mitigation in place. You get so much more oversight when it comes to the Planning Commission and City Council.

Council Member Duerr agreed and asked Mayor Schieve if she is trying to ask staff to expedite it.

Mayor Schieve stated yes and asked how we do this much quicker. We want to put something in place so in the long run it doesn't become problematic. What is the easiest way to do that without creating all the delay.

Ms. Fuss stated they will continue reviewing all data centers through a conditional use permit and in the meantime, it will take about six months to do a text amendment.

Mayor Schieve asked why.

Ms. Fuss discussed the public engagement process and explained that every time they try and shorten that it blows up and they end up spending twice as much time. She suggested having a realistic expectation that it will probably be about a six month process.

Mayor Schieve stated the hard part about that is it exhausts all of the resources we have on something that we have three of in the city. I feel like we are all aligned on our sustainability goals and initiatives so that one is a hard one for me to swallow so I can't support it.

Vice Mayor Taylor stated she does not understand what issues they have
