Mayor Schieve and Reno City Council:

I'm David Titzel, a volunteer with [Citizens' Climate Lobby](#) (CCL), Reno-Sparks Chapter. I'm speaking to you today to encourage the City of Reno to participate in an important federal grant opportunity. Time is short – by April 28 each city must submit its Notice of Intent to Participate (NOIP). The program is EPA's [Climate Pollution Reduction Grants](#) (CPRG), which “supports the development and deployment of technologies and solutions that will reduce GHGs and harmful air pollution, as well as transition America to a clean energy economy that benefits all Americans.”

These initial grants are modest: \$1M for each of the nation's [67 largest Metropolitan Statistical Areas](#) (MSA). But they're noncompetitive (guaranteed), and are important because they will prepare each state to compete or be competitive for subsequent competitive grants, such as these:

- \$27B: Greenhouse Gas Reduction Fund
- \$3B: Environmental and Climate Justice Block Grants
- \$5B: Climate Pollution Reduction Grants
- \$3.2B: Neighborhood Access and Equity Grant Program
- \$1B: Clean Heavy-Duty Vehicles (Class 6&7)
- \$3B: Grants to Reduce Air Pollution at Ports

These planning grants support each MSA developing an application and a plan to reduce climate pollution. Since most MSAs include numerous cities and even counties, the specific approach will vary between MSAs. It will likely leverage existing councils of governments or similar regional coordinating frameworks. EPA has held several preparatory webinars ([recordings and slides available here](#)), and on March 1, 2023 issued Climate Pollution Reduction Grant [CPRG program guidance](#).

I applaud the City of Reno for its past work in addressing climate change. However, we cannot let up in our response to the devastating impacts that will befall our community, our country and the world if we fail to take steps now to limit GHG emissions warming our planet. I encourage the City to work with others in our MSA to submit a Notice of Intent to Participate before the April 30, 2023 deadline for the noncompetitive planning grants, followed by applications and work plans approximately a month later. Notices of funding opportunity are expected later in 2023, with applications for the \$4.6B in competitive grants due in 2024Q1.

The Reno CCL chapter stands ready to support the City of Reno and other eligible entities within the state to help contribute to the grant application. And our national volunteer [Electrification Action Team](#) has offered to provide informational calls if those would be helpful.

Hello, my name is Thomas Albright, PhD. and this comment pertains to item D4: Placemaking Study.

I'm a City of Reno resident along with the rest of my family of four. I also work in the city limits and have children in the district. Three of us drive cars on a regular basis. Four of us use bikes or scooters on a regular basis to get around. We pay taxes and, as such, subsidize car travel and storage on streets maintained by the city, the county, and the state.

I am writing to express my support for accepting the placemaking report. However, **the implementation should not be supported unless a Center Street Cycle Track is included.** This option was promised to us years ago, has been studied extensively and found to be the clear favorite over alternatives, and is needed NOW.

We know that the Virginia Street Pilot project boosted ridership as it made many people more comfortable and safe riding their bikes downtown who otherwise wouldn't. However, the Center Street option will allow safe and connected biking in a way that is more sustainable for the community and its businesses. The evidence is clear that downtowns that prioritize people over speeding cars and empty cars are more attractive and better for more businesses (Volker and Handy, 2021, *Transportation Reviews*).

It is also an urgent question of safety. We have one of the higher pedestrian and bicyclist fatality rates in the country and it has spiked in recent years. Many UNR students and employees want to ride their bikes to work but are fearful about crossing through the current downtown. The current Center Street configuration as a three-lane one way street is not only unnecessary

for traffic demands but it produces unsafe conditions for motorists, bikes, and pedestrians alike by encouraging speeding.

For our safety, our health, and for the economic vitality of downtown, I urge you to support the Center Street Cycletrack for our community's future.
