I would like to express how appalling it is for this city to not have any resources for a family with 4 children one of whom is very ill with type 1 diabetes and needs stability to sustain his care, my son, spouse and 4 children were locked out of their home they have had for 6 years while waiting for help from EEPN process to be completed, the fine judge Hascheff had then locked out along with the corporation owning the dwelling most recently in the news on Ask Joe.

I have been paying for rooms for them, but those places are expensive and take advantage of people too- Our Place had no room for a family, Catholic Charities has no resources and couldn't advise anywhere else to go, Project Restart recommended voluntarily "surrendering" the children, RHA is no help although they are on the wait list, they have been offered a home with the childrens maternal grandmother in a rural community in UT- we are currently trying to get the funds to help them to get there however , there are other medical obstacles in the way at the moment.

So while you all pat yourselves on the back and make all the nice comments about each other and what you supposedly do for homeless while helping ONE vet what about families who don't have the internet to complete applications and jump

I understand that you are considering decreasing the size of the Sierra Vista Park, and the surrounding area at the next city council meeting. Pedestrians and cyclists are dying every week due to poor city planning and design. Nevada will never meet its goal of zero fatalities until it's cities are actually built in a way that protects people. Most roads in town do not even have a painted gutter and people on bikes are forced to ride with dangerous and unpredictable traffic. Sidewalks are not safe anymore either and in many places, they just end abruptly. I live near two grocery stores and do not even feel safe walking to either one of them. How have we built a city in such a small valley in a beautiful area that requires car ownership to survive? If we have room to widen a road, we have room to add protected paths for bikes and multi use paths. Some problems have difficult solutions, this problem does not. Studies have already been completed and the correct answer is in front of everyone. Car dependency and car centric infrastructure can't continue to be the default.

Complete the center Street project and start improving infrastructure around the city. The 2 or 3 dedicated paths we have around town do nothing when they're not connected to anything else. Please focus on making Reno a city that allows everyone to get around town efficiently in the manner they choose. There are so many forms of alternative transportation. Cars can't be the default anymore.
