My comments today concern the City's Landscape Maintenance Districts and the city's landscape contractor, Reliance Grounds Management.</p> <p>After my comments submitted to you during the June 7 Council meeting, new information came to my attention that is even more troubling.</p> <p>On June 1, I notified the DPR Director that the Northgate 19/La Salle Heights Landscape Maintenance District had not received ANY landscape maintenance service for the preceding 8 weeks. 8 weeks! In a June 6 email, the DPR Director informed me, quote, "According to our maintenance staff, the contractor confirmed that they serviced the area May 23...", unquote.</p> <p>Well, Reliance Grounds Management was probably not aware that I have approximately 90 photographs taken on May 18 that documented conditions within the LMD. May 18 was the SAME day that the DPR Director toured the LMD with me to observe these conditions first hand. And I also have approximately 70 photographs taken on June 2, documenting the very same conditions that existed</p>

on May 18. I provided those photographs to the DPR Director on June 11. So what we have now is a situation where, at BEST, Reliance Grounds Management provided grossly misleading information to DPR. And at WORST, Reliance Grounds Management flat out LIED to city officials. So the question now is, based on this new information, what will it take for this City Council to actually serve its constituents by demanding accountability from both Reliance Grounds Management and DPR? Because from everything that has been exposed to date, the longer you wait, the worse it gets.
