| <b>Your Comment</b>  | <p>Good Morning Mayor Schieve,</p> <p>I am contacting you today to ask for your leadership in creating a formal ban on the practice of keeping roosters in the Reno city limits.</p> <p>I understand that chickens are allowed. But where is the logic, or justification, for keeping roosters in the city limits? People who raise chickens in the city do bring with that hobby a serious rodent problem to all their fence sharing neighbors. We have to deal with that mouse problem first hand and daily. As this is the case, the neighborly thing to do by those with chickens would be to at least not also keep roosters in the city limits. Roosters are a well known noise nuisance and do not belong in a dense population area.</p> <p>Please stand up and take the lead on this issue for the majority of Reno citizens who do not keep chickens, and ban the keeping of roosters inside the city limits. It would be best to include an amnesty period allowing people to find a home for their rooster I believe.</p> <p>I first reached out to my Ward 3 rep on this a over a year ago. His office told me that I need to accept it, to be more understanding, that this is a cultural thing. I disagree, City of Sparks disagrees, and hope you would as well. I've also contacted Washoe County animal control. Animal control instructed me that they treat a rooster noise complaint like a dog noise complaint. I am required to file multiple complaints while keeping a written diary of the noise events. With the end result being eventually creating a legal case if the neighbor will not make the rooster be quiet.</p> <p>It is widely understood that roosters are a seriously loud, noise projector...how reliably they are noisy...and when. They are not at all like a</p> |

dog.

Could it be as simple as amending the existing chicken ordinance? Please help to move, and keep, this rural animal out of the city. Thank you very much.

RE: RFP 2023-01, Landscape Right of Way Maintenance  
As a property owner within Northgate 19/La Salle Heights Landscape Maintenance District, I strongly object to the City response in RFP 2023-01, Addendum 1. The bidder question and City's response are as follows:  
Bidder: Some of the areas in the RFP (especially in Stead) could really use a one-time cleanup prior to transitioning to into the maintenance phase... would the cost for the cleanup need to be included in our cost to maintain those areas in the RFP?  
City: The cost for cleanup should be factored into the overall cost to maintain. There should be no separate charge for initial cleaning.  
The City's response lacks clarity because neither the original RFP nor Addendum define the terms "one-time cleanup," "cleanup," or "initial cleaning." The RFP and Addendum do not identify what "cleanup" must be

completed; i.e., work that is separate and distinct from "maintenance." As a result, bidders have no clear direction on the city's expectations for "cleanup," and property owners within the nine Landscape Maintenance Districts, who are assessed semi-annual fees to pay for landscape maintenance, have no clear guidance to evaluate whether the City and the Contractor are complying with contract terms.
