I am told the proposed development is ANX23-00002, Valley View Estates Annexation, an 80 unit development. I am adamantly opposed to further development in this area. This entire area only has several small residential streets for ingress and egress. And all those streets exit onto Rio Wrangler, another two lane road, right next to the Damonte Ranch High School. These streets are already clogged with traffic, especially during school hours and commuter hours. Should there ever be any form of emergency, exiting this area will be all but impossible. Over the course of two days, Sparks Police arrested twenty-six individuals at a single Safeway store — most of whom were engaged in theft. Retail theft in Reno has also been a widely heralded problem. On the Nextdoor app, neighbors have been engaged in massive discussions about the local theft from grocery stores; and yet, we have seen no response from this city or from the Reno Police Department. Please take action to enforce the law and to crack down on crime within Reno. Particularly, please direct RPD Chief Kathryn Nance to do as the Sparks police have done in cooperating with local stores to hold thieves accountable for their crimes and to uphold the rule of law.

Residents of Reno and Sparks are celebrating the active response of Sparks to address crime. However, Reno residents are still waiting for our city to actively engage with local crime. Please take action immediately!

My public comment is a follow up to the Micromobility project approved during the last city council meeting and subsequently accepted by the Regional Transportation Commission as part of their RTIP. I feel that the council did the residents of the city a disservice by putting so much emphasis on which routes weren't included (in particular Center St/University) and not enough emphasis on which routes were included. Emotions were high around what many considered the bait and switch with Center St and I will admit that I was also caught up in those emotions. With the dust settled now, an even bigger problem is now apparent, which is the inclusion of Vine St in the plan. Vine St is the absolute worth route possible for the west side of downtown, the bridge across the freeway will never be suitable for being a "complete street" with safe and comfortable bike and pedestrian facilities without a complete demolition and reconstruction of the bridge. No matter what reconfiguration the city is proposing, the slope on the approach from the south will be steeper than ideal, the ridge between the southern approach and the main span will always have a large blind spot, the bridge will be too narrow to offer all the amenities the city is promising, and the bridge will bypass a direct connection to 7th St (a very popular route for cyclists to use).

The bridge is just the first of many concerns about a route on Vine St. The plans presented by the city depend heavily on "sharrows", which in a community with a much more developed culture of cycling and slow streets would be a perfectly acceptable solution, but in a community still developing a cycling culture and still very much with the mindset of moving cars as fast as possible, is not a great solution. Icing on the cake, if the renderings provided by the city are any indication, there aren't even plans to fix the fact that there are power poles in the middle of the sidewalks.

The decision to include Vine when Washington is already the preferred route used by cyclists, already has an intersection with modal filters installed (Washington and 4th), has an overpass over the freeway with none of the limitations that Vine St has, and is wide enough for the entire length that sharrows wouldn't be needed, and it is the obvious choice before you even consider that it connects directly to 7th St and will be much easier to enable future expansions than Vine (either continuing further north on Washington all the way to Rancho San Rafael or creating new micromobility infrastructure on 7th or a new bikeway connecting Washington and Ralston via Whitaker park and eventually paralleling the freeway the entire way to Sierra).

Vine is at best a short sighted decision at worst an extremely backwards decision.
