Hello, My Name is Kelly Hyatt,
I live on Toll Road off Geiger Grade South Reno. I work with the Wild Horse Connection as a diversionary feed/ water person as well as I help move the off the roads and yards in the toll/geiger area. I feed at an approved private property about 4 miles up from the intersection of Geiger and Toll (Equestrian). The road goes directly up into the Geiger Grade canyon. The wild mustangs can come down Toll road from the hills behind the toll road houses and even on roads that connect back to Pleasant Valley. We currently have over 100 horses that "mostly" stay up at our feed station, although a few times a week they just have to come down to get some grass and apples. We also have about 30 "stragglers" who have ended up in the streets and are crossing Geiger grade almost every night , on to Equestrian into the Curti Ranch development. That development opens up onto Veterans Parkway. While I am thrilled that you are considering a fencing project as well as an eventual under/overpass for the wildlife, I implore you to take notice that this project must be done NOW, not in two or more years. The initial fencing must be done now to alleviate the problem of over 100 horses crossing Geiger grade at 2am. This is a small project that will yield enormous benefits as soon as the fence and cattle guards are installed. While a fence all along the Geiger grade would be a benefit in stopping horses from crossing that major road, it will not alleviate the horses being on Toll road and so therefore i ask that you immediately begin approval on the proposed fence that Wild Horse Connection has presented, this is the same fence line that horse advocates have asked for since at least 2013 and it is the best way to keep horses from getting into the highways, local roads and homes/ developments that they are in right now!!! We must have fences to

protect the public and the horses. I feed every day (during feed season) twice a day and I provide water year round. I work a full time job in addition to at least 6 hours a day (3 before and 3 after) to help keep the public and the horses safe. I am grateful for the WHC that I am able to do diversionary feeding and I am grateful that you are looking into fencing. But it must be done sooner than later as I do not want a person to be killed when 30 , 50 , 80 or 100 horses are crossing the roadways in search of food or treats such as apples. the horses know that the apples are here now that harvest season is upon us and also there are still people who insist on providing water and food for the horses down in the developments of Curtie Ranch, the Foothills, Via Biancia MH park as well as in the homes all along Toll road and Kiviatt, Pinon and more, the fence will stop all of that immediately and then the WHC and other groups associated with them can focus solely on range management rather than moving horses off the roadways to protect them and the public. The proposed fence goes along a few private properties and some BLM parcels, and it would be much less expensive to "close up" the existing fence lines with new "range fence" and put in a few cattle guards then to fence 8 miles of Geiger Grade right now. Thank you for your support -- please see the photos of the horses and the MAP!
