To Whom It May Concern,

I am opposed to the proposed amendment for the Sierra Senior Care Planned Unit Development zoning district to allow for 96 unit multi-family complex. There are several reasons this request should be denied.

1) The original zoning was amended to accommodate the existing multi-family units and senior care facility. The original plan would not have been supported without the inclusion of the senior care facility. This is by definition a bait and switch.

2) Allowing the egress to 96 multi-family dwelling units to be located in County Club Acres blatantly disregards the residents in this established single family neighborhood. The amount of residents and traffic entering and exiting through CCA will have a negative impact on the neighborhood.

3) Mountain View Drive is a narrow and already dangerous road in a single family neighborhood. Adding 96 multi-family dwelling units with one of the two egress on Mountain View will compound the hazards of this road.

4) The traffic on Watt St will increase as this will become the most efficient way to access major roads and highways.

5) I attended the developers community meeting and reviewed their proposal. The traffic study and estimated number of tenants is skewed to

support their agenda.

6) Reno is in desperate need of senior care facilities.

7) The community should be the priority, not profit. This is an attempt to capitalize on the growing demand and need for housing to develop in a neighborhood that can't support 96 multi-family dwelling units. I am hopeful that Reno City Council will make decisions based on the best interests of families, neighborhoods, and community and not profit.

Business History

Response: Honorable Members, these calls does not belong to convenience store only. Calls are from Lakemill lodge (as presented on memorandum), which also houses 125 low-income families with casino workers, veterans, and seniors. Lakemill Maxi mart (convenient store) has its own dedicated telephone line (bill attached).

Reno Police Department calls for service

Response: Honorable Members; REMSA, Fire Department, and Reno Police Department are very essential for families who are staying there as for every human being. Majority of the calls are not related to the Convenience store. Convenience store did had an accident on August 29th 2022, which is still in Court of Law for Justice.

Comparison

Response: Honorable Members, Fireside Inn has 46 Rooms and a convenience store (assessor report attached). Lakemill Lodge has 125 Rooms and a convenience store. LakeMill Lodge is 2.7 times bigger in size as compared to Fireside Inn. Lakemill lodge has 171% more families by room volume as compared to 103% more total calls in year 2022.

Lakemill lodge is a Weekly/Monthly low income hotel/motel not an apartment, should not be compared with an Apartment complex. Different business.

Code Enforcement case

Response: Honorable Members, convenient store is in compliance. Inspected couple to times by city officials in last couple to weeks. No selling minor alcohol or tobacco violations at convenient store (Lakemill Maxi mart). Liquor licencse active since last 24 years with good standing with Code Enforcement, Fire Department, and Police Department.

If the intention is to maximize profit and utilize space, I can see why bringing in a housing unit seems like a good idea. I am here to say that I think there are other possible ways to achieve the same goal. I would suggest taking advantage of the amenities that are already available to you, beginning with the lake & the dog park. Locals who have been familiar with the area are eager to invest into the park's improvement; however, new people that recently moved into the area don't share the same interest. Adding something that the park-goers or dog owners enjoy would not only avoid interfering with the appeal of Virginia Lake, but it would contribute to the communities that care about the area and maximize profit at the same time, as well. Benefits for everyone.

Let's talk about some of the potential disadvantages. There are several high density units placed nearby; creating another unit is unlikely to draw people toward the park due to the potential safety risks, limited parking, and traffic conditions that will impede the park's natural & attractive features.

The 96-unit development will create more traffic in what already appears to be a congested road. This poses a safety risk for



My Name is Marshall Stevenson

I am, and have been the General Manager of Tonic Lounge for the last 10 years. Tonic is two doors down from the proposed club.

In those 10 years, I have seen 3 renditions of nightclub come and go in the proposed location. Singer, HQ, and Fusion were all run by FIRST TIME CLUB OWNERS, who thought they had it all under control. In each operation, the customers, and want to be customers, hung out not only inside the club, but around the outside of the business as well. They hung out in front of the club on the sidewalk, the alley, the parking lot, and the wing lot belonging to Arlington Towers. Many brought their own liquor, etc, as they either didn't have the money to buy drinks at retail bar prices, or it was just cheaper to party in the parking lot. Anyway, with no supervision, these characters got out of control. Fights became normal, and brawls became commonplace. Things got worse, and then there were shootings and stabbings and people attempting to run over others with their cars too. Even the owner of Fusion was stabbed inside her club. Police, Fire, and Ambulance resources were consistently called to this location to clean up whatever mess had happened that evening. It was Mayhem.

Many of my customers were unable to get by, on the sidewalk, as either they were blocked, or intimidated by the crowd hanging out in the alley, the sidewalk, and the parking lots.

My employees had threatened to quit, for their own safety, if the havoc was not stopped. Many brawls came from the proposed location, right across my front door, and went as far as the other side of Arlington and 2nd street. In those scenarios, I had to lock my front door, to protect my customers and my staff.

Faces, our next door neighbor closed last month due to lack of business, partly due to the ongoing problems from Fusion.

My question to the council is, Why would we even consider reopening this location as a nightclub again, Especially to first time club owners who think they have it under control?...AGAIN

What guarantees do we have that these problems will not happen again, risking City resources, and public lives? If you do allow it, What mitigation tools will we have, if these problems again reoccur?

Tools:

In the 1990's Easy Street was a club in the Keystone Village shopping center. They had a brawl and shots fired. The City closed this location decided to not let it be a nightclub again, and it is now a Theatre

In 1993 I opened a nightclub call Dick Clark's American Bandstand on Virginia Street in Downtown Reno.

The City made me hire 4 Uniformed Police Officers for 6 months, because they felt, due to the volume of customers that I had a powder keg on my hands. After the time period, employing 4 officers, they decided I had it under control.

Final: I am not afraid of competition from the location and I am pro business. I think we need more businesses open all over downtown. I just don't feel that a nightclub of this SIZE, which, in my opinion, can not generate the revenue necessary to pay the rent, bills, and staffing necessary to consistently curtail the bad activity happening inside and outside of the premises, and maintain normal operations profitably.
