Your Comment	<p>I could not be more proud of The City of Reno for unanimously adopting the Sustainability & Climate Action Plan in 2019. I am also proud that Mayor Schieve is part of the Climate Mayors network, an organization that committed to the climate goals of the Paris Agreement at a time when the US pulled out of the agreement.</p> <p>These actions proclaim The City of Reno's commitment to sustainability, but the progress update report published on January 23, 2023, shows that we are falling behind just as the state of Nevada is falling behind. The report says we'll fall short of the 2025 goal by 2-3%. But what about the 2030 goal of reducing greenhouse gas emissions 40% of 2030? At the state level, the shortfall only gets worse over time. The city's progress update report gives me no reason to believe the situation is any different for The City of Reno. I am concerned because I do not see a sense of urgency; there are no timelines for getting back on track.</p> <p>The City of Reno needs to inform the public about the specific steps and timelines they plan to pursue to get us back on track for reaching our greenhouse gas emission reduction goals in 2025 and 2030.</p>
