I have reviewed the January 23, 2023 City Manager's Office Memo titled Sustainability & Climate Action Plan 2022 Progress Update. I would like to know what specific steps the Council plans to take to help us achieve our 2025 goals. I did not see any steps outlined for reaching that goal or the goals for 2030. (Reduce Greenhouse Gas (GHG) emissions by 40%. (The status report does not extend to 2030.) My concern is that unless concrete action is taken immediately, =our current shortfall will expand. Now is the time to take meaningful steps. As an example, how do we plan to take advantage of new federal grant money to reduce GHG?

The presentation I heard was on the Zoom platform. Suzanne Groneman is dedicated to her job. My concern is that she did not seem to understand the simplicity of returning revenues gleaned from a carbon fee imposed upon

business. (Page 51 of the original plan.) It's very simple, people receive checks which they can cash.
